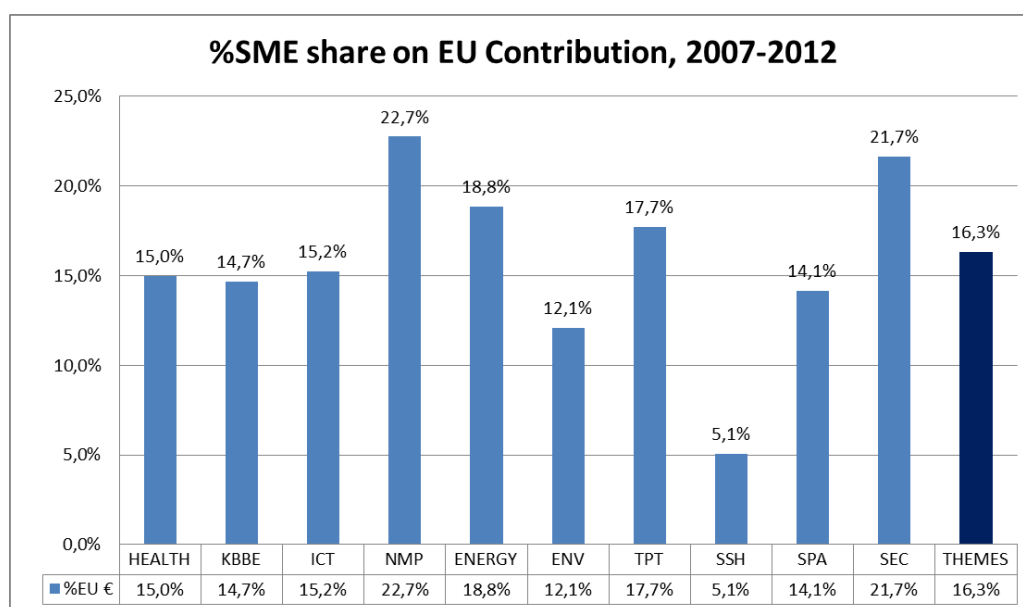
## Executive Summary

The European Commission has irrefutably paid special attention to the funding for SMEs under the Seventh Framework Programme so far, and intends to continue to do so. In addition to the SME specific measures under the Capacity programme (through Research for the benefit of SMEs), the Decision establishing FP7<sup>1</sup> as a matter of fact provides for a target of at least 15% of the funding of the Cooperation programme to go to SMEs.

The aim of the SME Progress Reports is to monitor the participation of SMEs in the Cooperation Programme within the Seventh Research Framework Programme (FP7). This ninth SME progress report analyses the SME participation in Grant Agreements that have been signed up to the end of September 2012.

In our previous report – the eight SME progress report published in January 2012 – we reported for the first time that the 15% target was reached with 15.2% of the total Cooperation Programme used budget going to SMEs. This has further progressed, to an extent that today the percentage of used Cooperation programme budget going to SMEs has reached 16.3%, which represents about 3 Million Euros total.

The graph below shows the overall percentage of the EU contribution going to SMEs and the percentage for each of the ten thematic priorities under the Cooperation Programme.

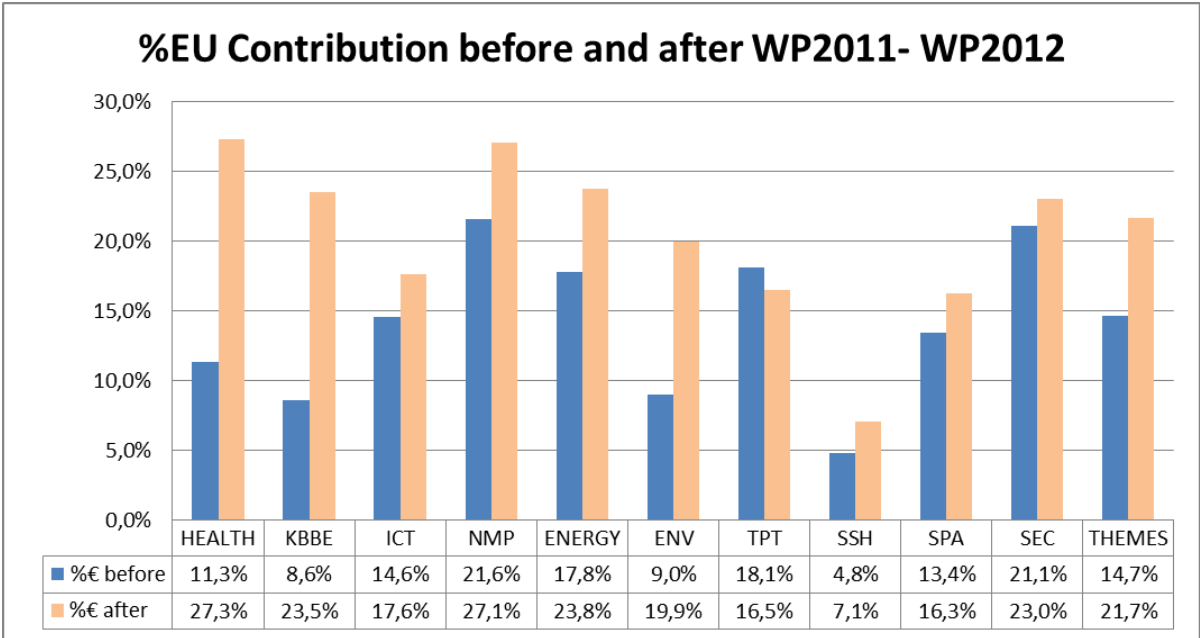

By the end of September 2012, SMEs made out 18.5% of all participants to the Cooperation Programme, as will be detailed in Chapter 2 of this report.

This report also provides in-depth statistics about the composition of project consortia: 74.5% of all the Grant Agreements involve at least one SME and 11.1% of all the projects have an SME as coordinator. The average EU contribution going to SMEs participating in Thematic Research Projects so far has been about 275,000€ per project.

When looking at the Seventh Framework Programme in its entirety – including Research for the Benefit of SMEs and the Marie-Curie Actions – our conclusion is that of the about 91,000 participants, 16,000 are SMEs, receiving an average EU contribution of 253,000€. The SME participations represent 10,807 individual SMEs out of the 27,549 individual organisations participating in FP7.

Graph 2 below shows the difference in terms of the level of EU contribution going to SMEs between the periods before and after the implementation of the work programme for 2011. The increase of the budget going to SMEs through calls issued under the work programmes for 2011 and 2012 has been significant.

This trend can be attributed to the increase and strengthening of measures in favour of SMEs under the two most recent Work Programmes, and is particularly visible as far as the Thematic Priorities HEALTH, KBBE, ENV and SSH are concerned. SME-specific measures taken range from the selection of topics of particular relevance to SMEs to calls ring-fencing specific SME budgets; yet another measure has foreseen as a requirement for project participation for an SME to be the overall coordinator. Our statistics suggest that SMEs have responded very positively to these specific measures, and have massively stepped up their participation to projects as a result.

## Chapter 1. Key Figures on the SME participation in FP7

### Overall overview FP7

The Seventh Framework Programme has five Specific Programmes. The table below summarizes the SME related key figures for the entire Framework Programme and for each of these Specific Programmes.

As expected, the Capacity programme – with its SME specific measures under Research for the Benefit of SMEs – devotes the highest percentage of its EU contribution to SMEs (31.3%), i.e. no less than 870 million € in absolute terms.

The highest EU contribution in absolute value spent on SMEs under FP7 however (i.e. about 3 billion Euros) can be brought back to the Cooperation Programme, which devotes 16.3% of its overall budget to SMEs.

The EU contribution to SMEs under the People programme can mainly be attributed to the IAPP and the IAT programmes, which include specific measures meeting SME needs. For this very reason, the data contained in chapter 13 focus exclusively on those two programmes.

## Chapter 2. SME Participation in the Cooperation Programme (Thematic Priorities)

The table below provides the complete overview of SME participation per theme, in terms of EU contribution and in terms of SME participation, both in absolute value and in percentages.

The percentage of EU contribution going to SMEs out of the total contribution per theme relatively is the highest for NMP (22.7%), followed by SEC and ENE. However, it is the ICT thematic priority, which ranks only fifth with its 15.2%, which provides the largest absolute EU contribution to SMEs, with over 830M€, followed by Health and NMP.

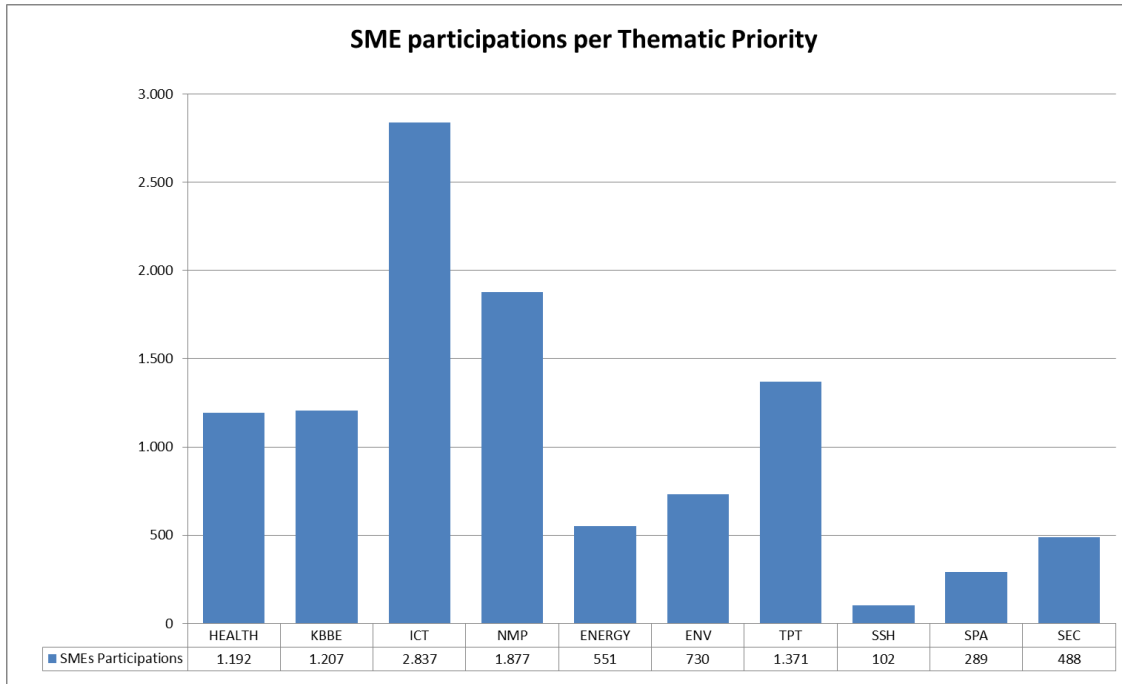
The percentage of SMEs participating per theme is relatively the highest for NMP (26.9%), followed by TPT and SEC. However in absolute terms, it is once again the ICT thematic priority – more than 2,800 SMEs participating, which stands out as most important, followed by NMP and TPT. Graph 3 and 4 provide further illustrations of the latter.

Health and SEC are the only thematic priorities where SME participants receive on average more than any other participants, while it is within the KBBE thematic priority that the average number of SMEs per consortia is the highest, which can be explained in part because the consortia under that thematic priority are also the largest on average (see graph 10 below).

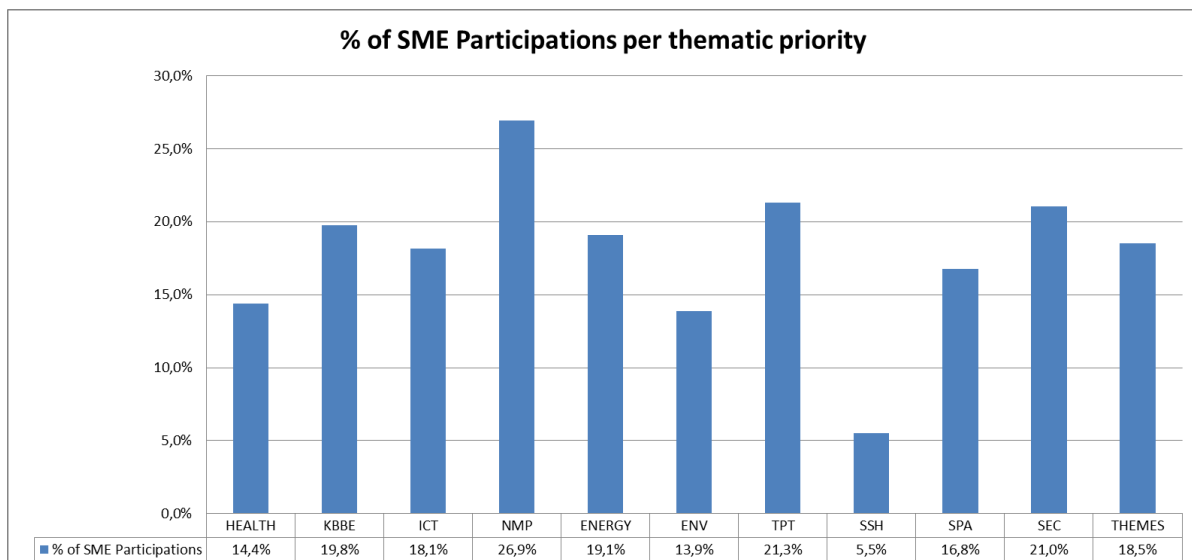


## SMEs represent 18.5% of all participants in the Cooperation programme

Below table displays the data contained in table 2 (above) graphically. With its higher budget, ICT attracts the highest number of SMEs, but it is NMP which dedicates the highest percentage of its budget to the support of SMEs.



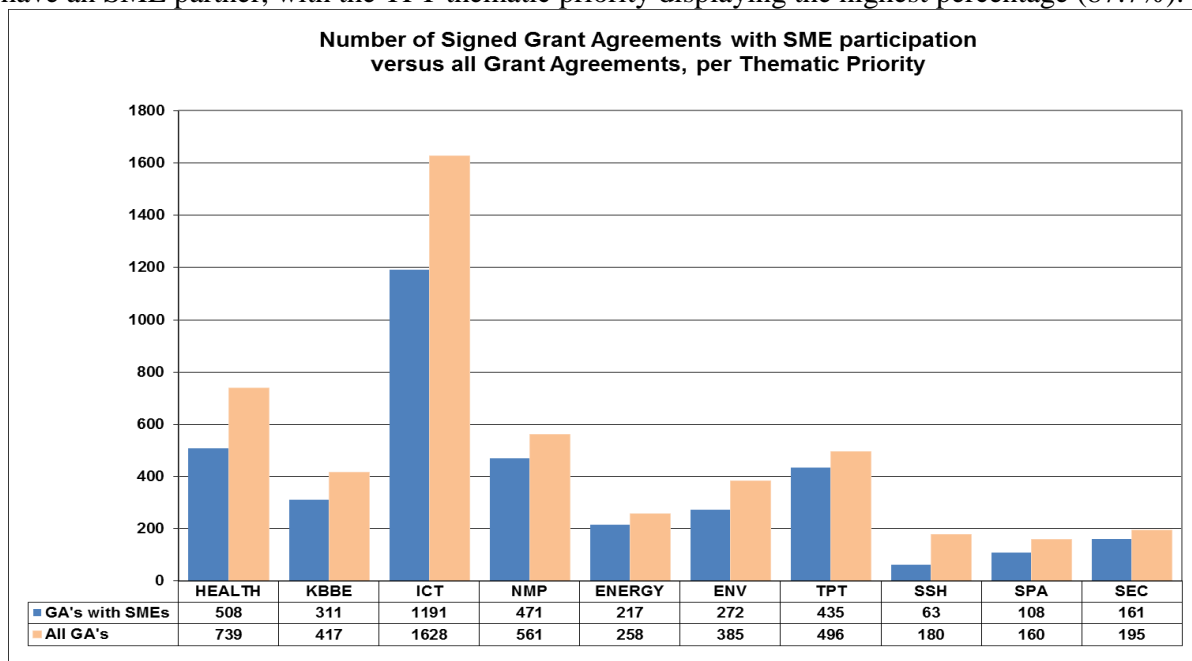
*Graph 3: SME participations per Theme*



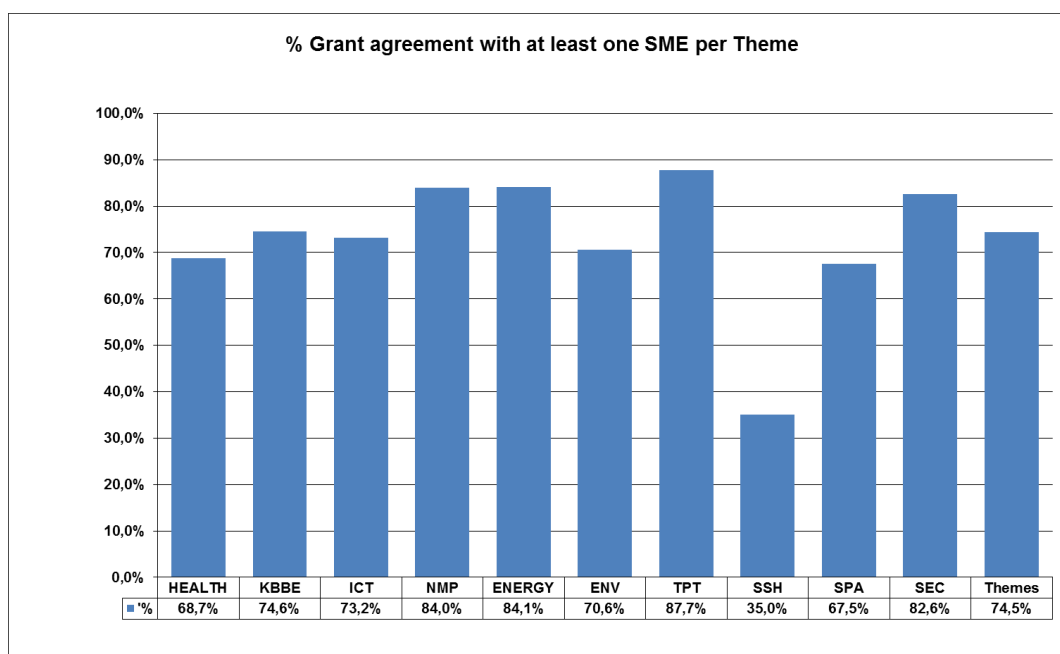
*Graph 4: Participations per Theme – SMEs versus all – in percentage*

## 74.5 % of all signed grant agreements involve at least one SME

Our most recent statistical analysis demonstrates that SMEs are fairly well represented in the consortia that have signed grant agreements with the European Commission under the Cooperation Programme. Whereas the ICT thematic priority – which in absolute value counts the highest number of SMEs as project partners under the more than 1,100 grant agreements signed – seems to stand out as particularly SME-friendly, our conclusion is that actually all themes – with the exception of SSH – welcome high SME participation, as 67 to 87% of the consortia involved have an SME partner, with the TPT thematic priority displaying the highest percentage (87.7%).

# Not the 'usual suspects': good turnover of participating SMEs

The recurrence rate of an organisation is the average number of projects in which an organisation participates.

## Recurrence within the Thematic Programmes

The Thematic Programmes have about

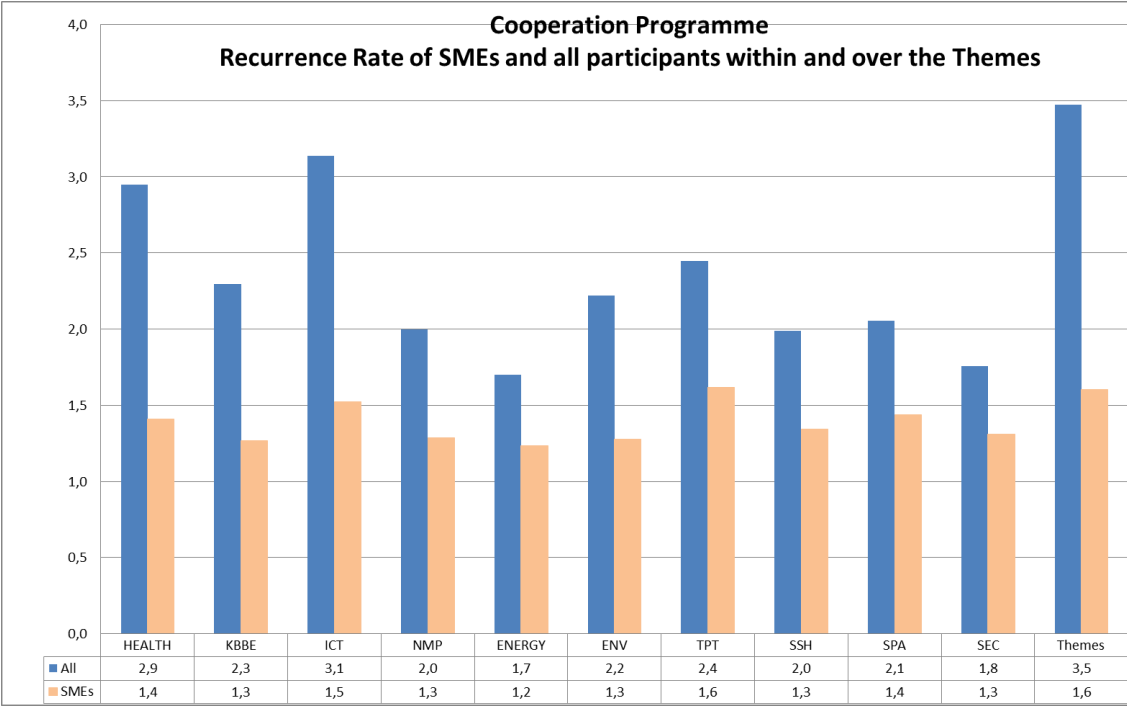
- 57462 participations
- 16558 organisations (individual participants)
- 10644 SME participations
- 6641 individual SMEs

### SMEs

SMEs often participate in more than one research project. On average, within the same Theme, an SME participates in 1.4 projects. There are also SMEs which participate in projects of different Themes. Overall, the global 'recurrence rate' of SMEs in the Cooperation Programme (over the ten Thematic Priorities) is 1.6. This means that, on average, an SME participates in 1.6 projects.

### All organisations

On average an organisation involved in the Cooperation Programme participates in 2.2 projects. Organisations regularly are active in more than one Thematic Priority (e.g. universities); on average a participating organisation is involved in 3.5 Grant Agreements within the Cooperation programme.

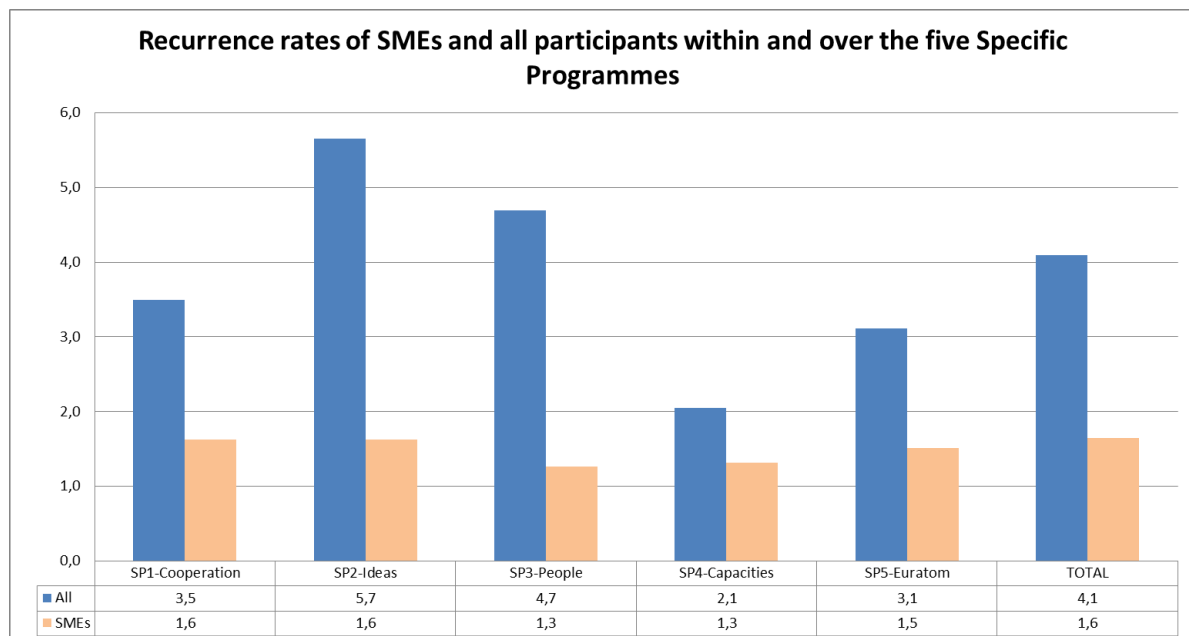

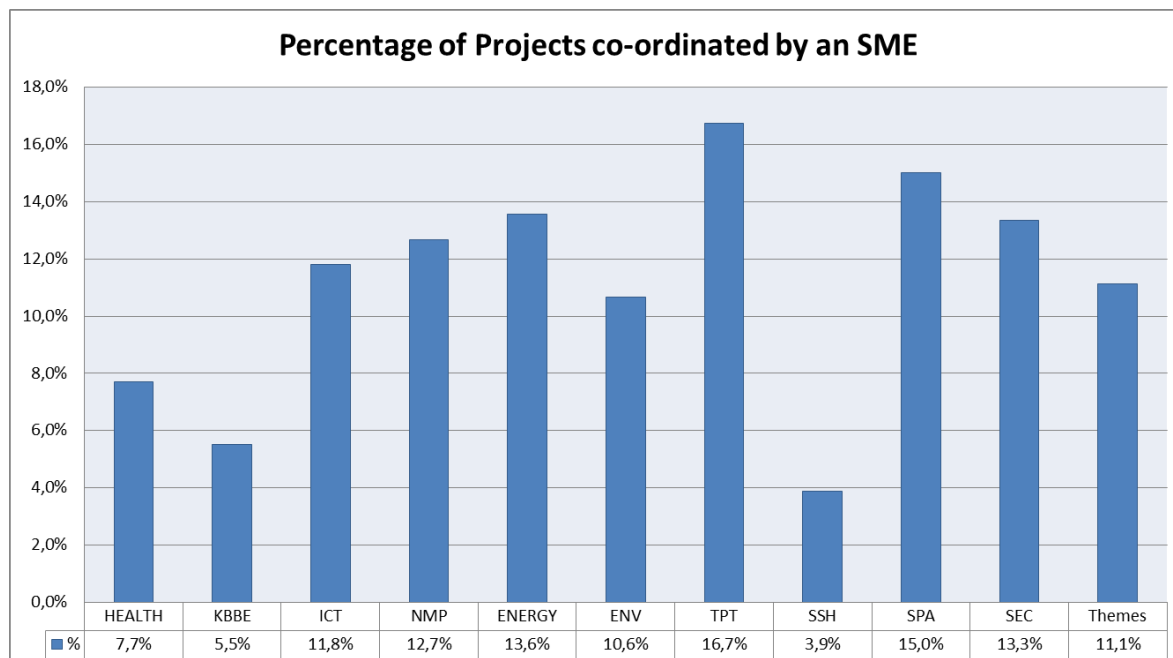
Over the whole of FP7, an organisation participates on average in 4.1 Grant Agreements.



*Graph 6: Recurrence rate of SMEs and all participants to the FP7 Specific Programmes*

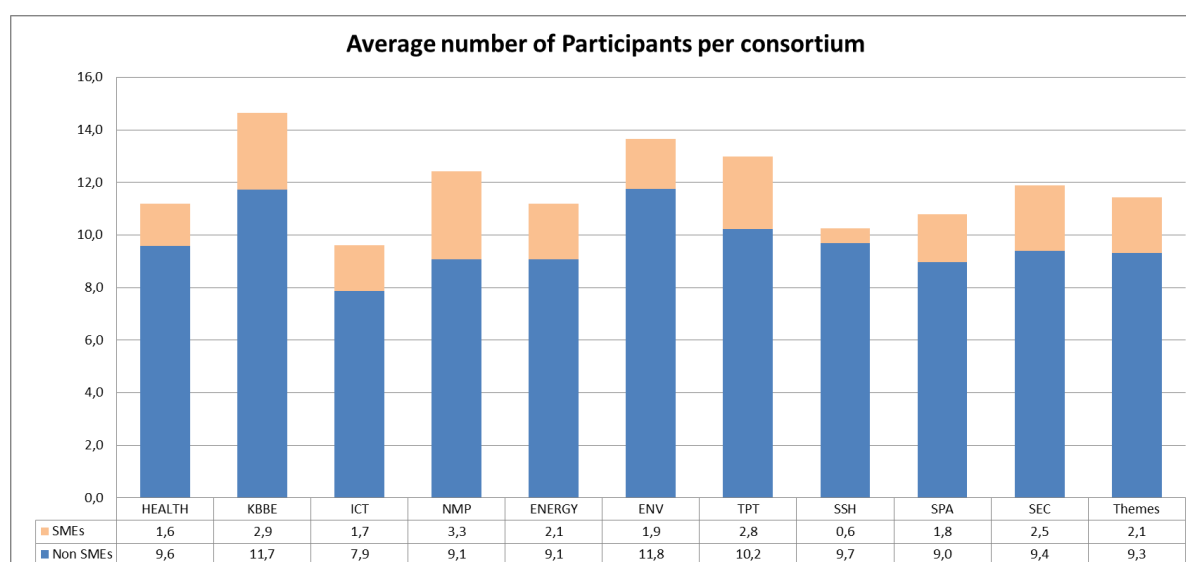
## 11.1% of the FP7 projects are coordinated by an SME

There has been a significant increase in the percentage of SME coordinators since the last report, with the percentage of SMEs coordinators going from 10% in January 2012 up to 11.1%.by the end of September 2012.



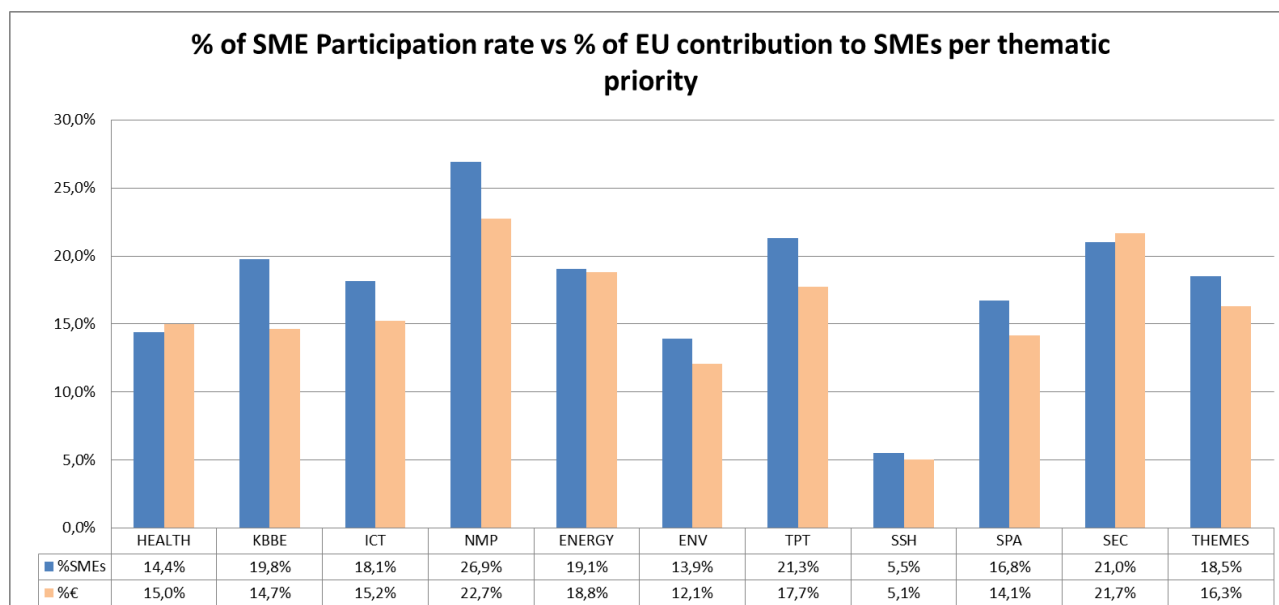
*Graph 7: projects coordinated by an SME, expressed in percentage of the total number of projects*

## The NMP thematic priority draws most SME participation and devotes relatively the most of its budget to SMEs

While illustrating that SME participation to a project in relative terms translates into higher EU contributions, the graph also provides an indication of the average amount of money received by the SMEs under the different themes: the higher the difference between the two percentages, the lower the average contribution received by each SME (KBBE, NMP, TPT). Only in two themes (Health and SEC) the percentage of EU contribution going to SMEs is higher than the share of participating SMEs.

### **SME participation and EU Contribution per Country**

Tables 3 – 6 below show the SME share of the EU Contribution in absolute value and as a percentage of the total, and the percentage of SME participation per country for all Member States and FP7 associated countries.

These country statistics, which had already been included in the previous report, reflect a specific request from the Member States. They enable each Member State to distil relevant information on the participation of its own organisations/SMEs in the Framework Programme.

Since many country-specific factors have an impact on the participation of organisations/SMEs to the Framework Programme (i.e. for instance the number of SMEs, the size of the university population, the availability of other national or international funding opportunities in each country and in specific periods of time, or the number of overall applications), it makes little sense to compare between countries.

The analysis of the specific factors and the influence they have on the reported figures are issues that go well beyond the scope of this report.

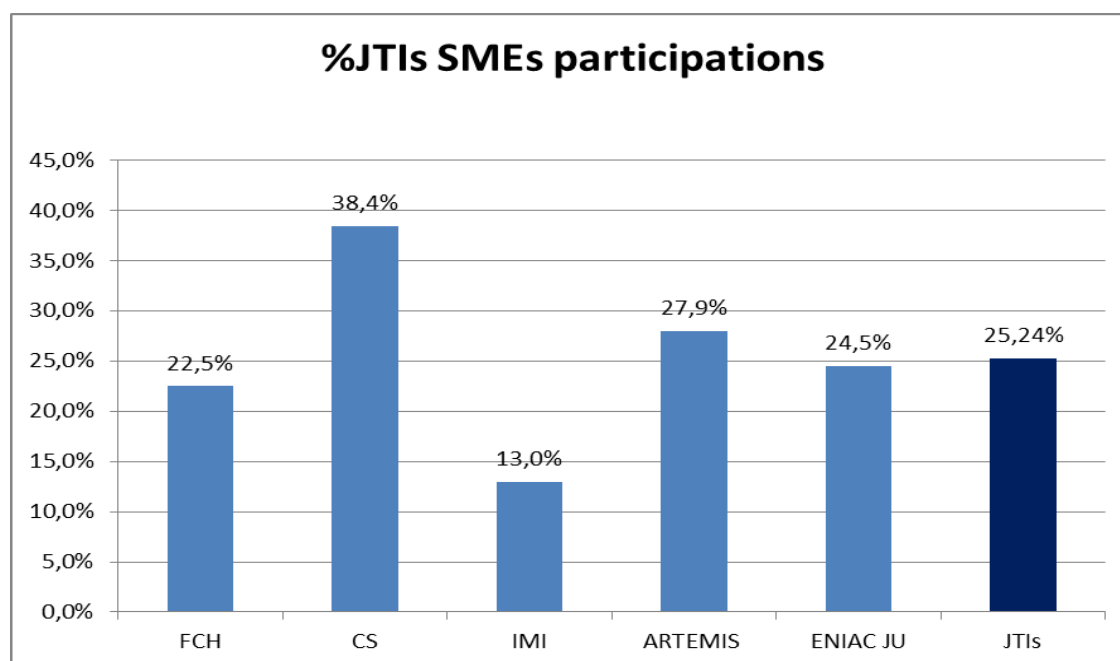

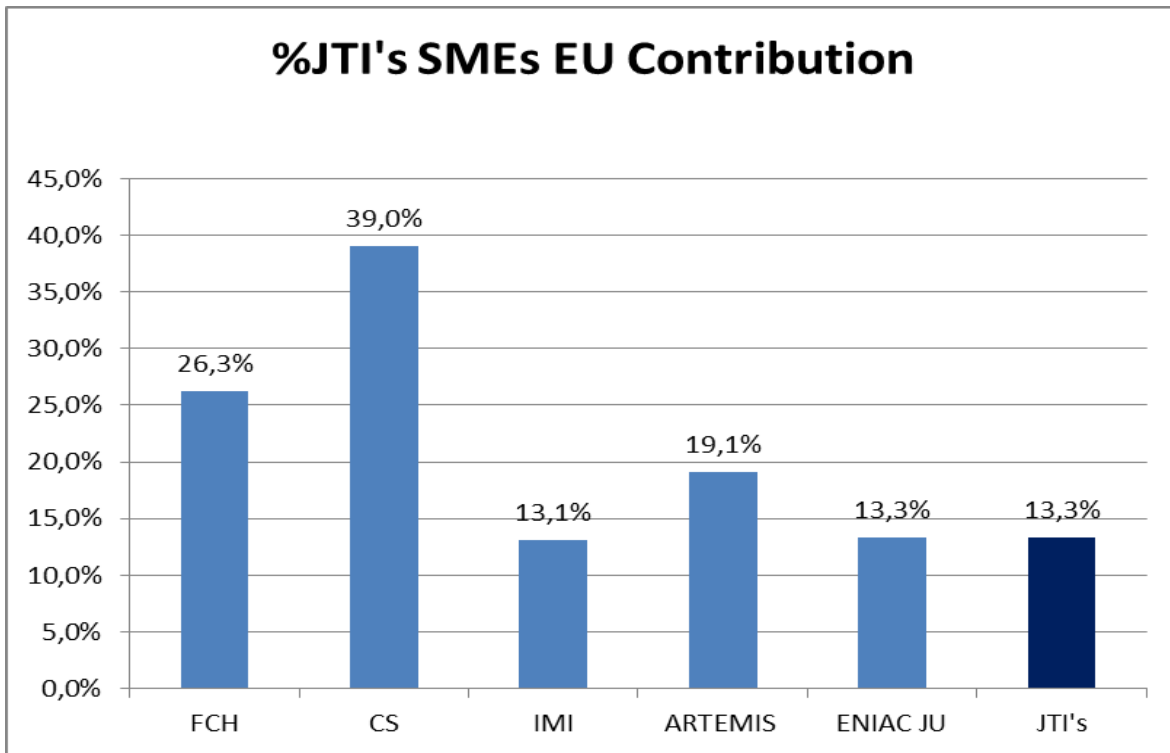
