



Domains: Physical Sciences & Engineering, Life Science, Social Sciences & Humanities


- Attract/retain next-generation leaders

Funded proposals per country of host institutions for all Starting and Advanced Grant calls



Simplifications and Specificities



- FP7 simplifications apply: flat rates Per Diems, extrapolation 2&3 methods, system for SME owners without a salary, Average personnel costs, RCC Committee etc.
- In addition ERC specific rules:
 - Project reporting period 18 months
 - Scientific report separate from financial less Scientific reporting (2x)
 - 20% flat rate for indirect costs/overheads
 - Helpdesks for Pls & Hls
 - Recruitment costs eligible if in GA ~(StG)
 - Grant portability Pl's independence
 - Mono-beneficiary grants (99%)







Common & Specific errors



...ERC salary top-ups/supplement payments, teleworking team, entertainment/excessive costs, visiting experts costs, common labs/facilities/ machines, double claim of costs...

Austrian stats to date:

not a pattern but a good signal to avoid similar errors:

- parts of a big machine reported as Consumables while also depreciated according to the accounting policy – double claim.
- Items reported as Consumables while should have been reported as Equipment and depreciated





New initiatives:

ERC Proof of concept

Maximising the ERC's role in the innovation chain



- Initiated to help ERC grant-holder to bridge the gap between their research and the earliest stage of a marketable innovation
- Supporting grant-holders during the predemonstration
- Up to 150.000 Euro per grant
- One step evaluation
- Second call in Autumn 2011





New initiatives: ERC Synergy Grant



- ERC Synergy aims to enable a small group of PI's and their teams to bring together complementary skills, knowledge, and resources in new ways, in order to jointly address research problems
- Investigator driven frontier research
- 2-4 excellent teams with complementary skills
- Interdisciplinary research with added value
- Grants of up to EUR 15 million max for up to 6 years
- Indicative Budget: EUR150 million
- Average budget requested: € 8.3 million
- Call closed: 1/2012 > 710 submitted
- Evaluation ongoing
